To get a better understanding of U.S. federal tax rates, consider the 2015 tax brackets for taxes due April 15, 2015, such as the one provided by Bankrate. A single filer with income up to \$9,075 pays taxes at the rate of 10 percent. On income above that, up to a limit of \$36,900, the filer pays 15 percent. From \$36,901 to \$89,350 the filer pays taxes at the rate of 25 percent. There are seven rate brackets in all, with the maximum rate of 39.6 percent on all income above \$406,751.

Average Tax Rate Is Generally Much Lower Than Marginal Rate. As an example, the graph below shows a married couple with two children earning a combined salary of \$110,000. They face a top marginal tax rate of 22 percent, so they would commonly be referred to as being in the 22 percent bracket. But their average tax rate the share of their salary that they pay in taxes is only 6.2 percent, as explained below.

The Tax Cuts and Jobs Act (TCJA) introduced on January 1st, 2018 reduced the United States federal corporate income tax rate to 21 percent from 35 percent. Still, 44 of the 50 US states levy additional corporate income taxes which brings the average rate to 25.7 percent. Corporate Tax Rate in the United States averaged 32.68 percent from 1909 until 2018, reaching an all time high of 52.80

### **What is the difference between marginal and average tax**

The average tax rate is the total amount of tax divided by total income. For example, if a household has a total income of \$100,000 and pays taxes of \$15,000, the household s average tax rate is 15 percent. The marginal tax

rate is the incremental tax paid on incremental income. If a household were to earn an additional \$10,000 in wages on which \$1,530 of payroll tax and \$1,500 of income tax was paid, the household's marginal tax rate would be 30.3 percent.
