Tenant s Notice of Objection to a 14 Day Eviction Notice. Usually, tenants can object to 14 day eviction notices. Tenants can object when they don t agree with the termination. The objection notice must be in writing and set out the reasons for objecting to the termination. It must be sent to the landlord before the termination date set out in the notice (before the 14 days are over). If a tenant does not object before then, the tenant must move out.
