Social Security (Old age, survivors, and disability insurance): 6.2% on \$128,400 for 2018(employee & employer) 12.4% on \$128,400 in 2018 for self employed. Medicare basic hospital insurance 1.45% on all wages (employee & employer) Additional 0.9% Medicare tax on wages in excess of \$200,000.
