What is a Book Contract in Publishing

The contract is then returned to the publisher for the publisher's signature. At this point, the contract is considered executed, and the author gets a copy (again, the paperwork goes through the author's literary agent). At this point, as well, any advance monies that are contingent upon signing are processed (though generally there's a wait before the author sees a check).

Book Publishing Contracts Checklist of Deal Terms

If the book includes advertising or other third party content (other than excerpts from other works published by the Publisher), Author gets 50% of fees paid to Publisher. F. Authors and Illustrators of children's books generally share revenue 50/50, unless either hires other to do work.
