### **Gay Marriage Is Legal in All 50 States Supreme Court**

In the 5-4 landmark decision, the majority of justices ruled that states must license same-sex marriages and also recognize gay marriages performed legally in other states. "No union is more profound than marriage, for it embodies the highest ideals of love, fidelity, devotion, sacrifice and family," Justice Anthony Kennedy wrote for the majority.
